Entries: \$100 / division. Refunds less \$35 if before closing date. Make checks payable to IEA and mail entries to Robin Thomas. Entries will be limited to 100. Negative Coggins test within 12 months of show date required for all horses (**horse name on entry must match name on coggins**). \$10 lost pinney fee.

Tentative Time Schedule: Friday: Course opens, 3:00 p.m.; Saturday: Dressage, 7:30 am; Cross Country, 10:30 am; Stadium, 1:00 p.m. (All times approximate.) Note that Starter divisions will likely ride their stadium round before cross country.

Awards: Ribbons to 8 places in each division.

Ride Times: Provide **legible** e-mail address.

Stabling: On grounds, reserve in advance, \$35 for one day/night beginning at 12 noon on Friday.

Non-Stabled Horses: Grounds fee \$10.00 if showing from trailer. Include with entry.

Accommodations: Red Roof Inn (812) 526-9747; Holiday Inn Express (812) 526-9899; Best Western (812) 526-9883; Hampton Inn (812) 526-5100; Camping – Hoosier Horse Park (812) 526-8034 (camping must be reserved via the horse park, not the show staff.)
